## IMPORTANT UPDATES

### NEED HELP WITH FUNDRAISING?



Looking for new fundraising ideas? Want help developing a fundraising strategy to support your chapter's dynamic, exciting programs? Come to the next workshop in the Audubon California Capacity Building series! On **November 7, 2015**, Paquita Bath of Aligning Visions will lead an interactive fundraising workshop in Southern California followed by six months of additional guidance and support. These sessions will be collaborative and personal. We encourage multiple leaders from each chapter to attend. The Chapter Network Team will be reaching out to potential participants to ask what fundraising topics the network is most interested in, and to discover what strategies can be shared for group learning. This is an opportunity to help shape the trainings to best fit the needs of your organization.

### 2016 COLLABORATIVE FUNDING GRANTS



Audubon CA welcomes proposals from chapters (single or in groups) for FY16 Collaborative Funding. Proposals should support conservation projects (defined broadly to include education, citizen science, policy, habitat restoration) and ideally will provide an opportunity to engage your members and the public, to promote our shared mission, and to align national, state and chapter priorities. For your request to be considered, we must receive documents by **October 31, 2015**. ### PROPOSITION 1 FUNDS FOR YOUR PROJECTS



Governor Brown signed a state budget for the 2015-16 fiscal year that includes the first year of funding from Proposition 1—the water bond that passed in November 2014. On 7/29, Audubon CA sent out an email to all chapter leaders concerning a considerable amount of grant opportunities that have recently been announced. Many agencies are now beginning to issue calls for proposals. Please let me know if you did not receive the email or would like more information. ## CALIFORNIA CLIMATE CHANGE LEGISLATION



Global warming is expected to threaten 170 California birds with extinction by 2080, and expanding the state's climate change and carbon pollution policies is one of the most effective tools we have for protecting our birds. Through in-district meetings with legislators, calls to district offices, and Letters to the Editor or Op-Eds to local newspapers, many of you have already taken action on climate change legislation. We are supporting a broad swath of bills including SB 32 – Pollution Reduction, SB 350 – Petroleum Reduction/Renewables, SB 788 – No More Offshore Oil or Gas Extraction. ## SOUTHERN CALIFORNIA CHAPTER CLIMATE CHANGE SUMMIT



Audubon California and California Chapters have been awarded two Climate Grants from NAS to conduct California's first ever series of regional Chapter Climate Change Summits. The primary objective of the Summits is to offer a personalized and regionalized training which provides each California chapter a clear understanding of the science and effects that climate change has on their local birds and habitats. Attendees will become focused chapter activists, enthusiasts, and communicators who are motivated and committed to develop and implement effective climate change programs and action campaigns in their communities. ## CULTURE SHIFT & INCLUSION TRAINING



Are you looking to attract different audiences to your chapter events? Do you want to recruit younger board members? In 2013, Audubon CA conducted a survey of chapter's priorities and goals. 90% of chapter leaders stated that their most important goal was to diversify their boards and membership in age and ethnicity. ### HAVE YOU COMPLETED YOUR CHAPTER'S ANNUAL REPORT FOR FY15?



You should have recently received an email from NAS to complete your Chapter's Annual Report for FY15. The online Chapter Annual Report Forms for FY15 are now available for Chapter use. Please remember that in order to be recertified as an Audubon Chapter, every Chapter is required to submit an Annual Report each year. The deadline for submittal is **November 30, 2015**. Chapters may request an extension from Chapter Services. It is also important to note that Baseline Funding will be directly deposited into your Chapter's checking account within 2 weeks following submission of all components of the Annual Report.

### UPDATE YOUR CHAPTER LEADER LIST



It's that time of year where your chapter most likely has new board members and leaders. NAS Chapter Services maintains a comprehensive list of all Audubon Chapter leaders which is updated weekly. It is important to keep your Chapter Leader List updated in order to keep your board and membership updated with the most recent news and chapter training materials, including free training webinars for Chapter Leaders. As changes happen throughout the year, and/or as soon as possible after your Chapter has held an officer election and appointed committee chairs, you will need to complete a [Chapter Leader Report](#) form found on Audubon Works and email it to Chapter Services.
